Key to the Courses

Orange courses relate to Good Governance

These sessions support trustees, paid staff and organisations to practice good governance.

Pink courses relate to Volunteering

These sessions enable strategic volunteering developments and promote good practice.

Purple courses relate to Engagement & Influencing

These sessions grow the third sectors' skills and capacity to influence policy, public services and participate with disadvantaged and minority groups.

Blue courses relate to Sustainable Funding

These sessions support organisations in building their capacity to effectively generate and manage resources needed to thrive.

October Training Courses

Developing a Sustainable Funding Strategy Thursday 3rd October from 10am to 3pm

The course is aimed at organisations seeking to diversify their income and to identify new approaches to income generation.

By the end of the session, you will:

- understand what a sustainable fundraising strategy is and why every organisation needs one
- learn how to explore and extend your fundraising options
- be able to construct a realistic and sustainable fundraising strategy

Managing Risk

Thursday 10th October from 10am to 1pm

This course is for staff or volunteers of third sector organisations who want to understand how to plan systems for managing risk.

By the end of the session, you will:

- Be aware of risks, their likely impact and the importance of proactive action
- Understand how to introduce a risk framework using tools and techniques to assess, evaluate and manage risk

Monitoring and Evaluation

Tuesday 22nd October from 10am to 1pm

The session will look at why organisations monitor and evaluate their work, who needs this information and how to create an evaluation framework to report on an organisation's achievements.

By the end of the course, you will be able to:

- Understand what can be measured
- Understand the different methods of measurement
- Design a simple monitoring and evaluation system

Wellbeing in the Workplace

Thursday 7th November from 10am to 3pm
This course will raise awareness of the importance
of looking after the well-being of staff and volunteers.



By the end of the course, you will:

- Understand mental health and how poor mental health can affect well-being
- Be aware how stigma surrounding mental health impacts on people's wellbeing.
- Have knowledge of tools and guidance for daily well-being management to build a work place based on positive wellbeing.

November Training Courses

Being a Trustee

Thursday 14th November from 10am to 3pm

This course will take you through the legal responsibilities you have when you are a trustee as well as your role and the responsibilities you have towards your organisation.

By the end of the session you will:

- Understand trustee roles and responsibilities
- Appreciate what trustees can be liable for, and how to limit risks
- Understand the principles of governance, the roles of specific officers, and differences between board and subcommittees
- · Know what is needed for trustee recruitment and induction

Reporting to the Charity Commission

Tuesday 19th November from 10am to 3pm

This course is aimed at incorporated organisations that have a duty to report annually to the Charity Commission.

By the end of the session, you will:

- Have a clear understanding of what information the charity commission requires from your organisation
- Understand the impact that reports generated late can have
- Be aware of systems for reporting to the charity commission

Preparing your Organisation for Volunteers

Thursday 21st November from 10am to 3pm

By the end of the course, you will:

- Be able to develop a volunteering policy
- Have considered what other policies might be necessary
- Understand key legal issues relating to volunteers
- Identify volunteer roles and draw up volunteer task descriptions
- Be able to assess and manage risk associated with volunteers

Finance Management for Charities

Thursday 28th November from 10am to 3pm

An introductory course for those who wish to learn how to implement simple financial management and control techniques.

By the end of the session you will be able to:

- Understand the concept of financial management & controls
- · Implement simple management techniques and controls
- Produce appropriate reports for your governing body
- Ensure your organisation works to good practice standards

December Training Courses

Equality and Diversity in your Workplace Tuesday 3rd December from 10am to 1pm

This session focuses on why equality and diversity matters and how to achieve it in your workplace for staff and volunteers.



By the end of the session you will be able to:

- Understand what equality and diversity mean
- Understand the impact of non-inclusive practice on staff & volunteers
- Consider equality, diversity & inclusion impacts of workplace practices
- Understand how to recruit diverse people
- Understand how to support staff & volunteers from equality groups
- Adapt recruitment, selection, and workplace practices to meet the needs of staff and volunteers from equality groups

January Training Courses

What is Community Development?

Tuesday 14th January from 10am to 1pm

This course is suitable for activists, community groups and leaders who are working together to bring about a difference.

Content:

- · Key purposes of community development work
- The values and principles of community development
- Different types of communities
- · What community development workers do and the skills required



Volunteer Recruitment, Selection & Induction Thursday 16th January from 10am to 4pm

Attracting a broad diversity of volunteers can be a challenge. The course will help you to plan recruitment and to think about materials and approaches that will reach the volunteers you want. It looks at different steps in the recruitment process, including 'vetting', interviewing, and matching volunteers to volunteer roles.

By the end of the session, you will:

- Be familiar with methods to attract a diversity of volunteers
- Recognise 'selection' as a two way process
- Understand the use of vetting procedures including CRB checks, and recognise their limitations
- Understand the purpose of volunteer agreements and inductions
- Recognise potential uses and abuses of personal information
- Recognise ways in which volunteering can be made accessible

Safeguarding: Organisational Implications –FREE



Tuesday 21st January, 9:30am to 12:30pm

By the end of the session, you will be able to:

- Understand the context of safeguarding in Wales, legislation and guidance
- Explore how to implement the policies and procedures required
- · Discuss confidentiality, reporting and referrals

Disclosure and Barring Service Information –FREE



Tuesday 21st January, 1pm to 4pm

By the end of the session, you will understand:

- How DBS checks contribute to safeguarding (what it is, what it can tell us, what it is not)
- How to use DBS checks to make a placement/employment decision (regulated activity, risk assessment, relevant offences)
- Best practice in response to DBS check content

Business and Strategic Planning

Thursday 23rd January from 10am to 3pm

This course will help organisations understand the importance and benefits of long-term planning and provide them with practical resources to plan more effectively within their own organisations.

By the end of the session, you will:

- Understand the difference between business and strategic plans
- Understand the purpose of business and strategic plans and why every organisation needs one
- Be able to develop comprehensive business & strategic plans

Skills to Participate: Community Engagement

Thursday 30th January from 10am to 3pm

Community development involves the active participation of individuals in their own community. This course will help you to consider barriers to participation and ways to overcome these.

By the end of the session, you will:

- Consider power relationships in communities and their impact
- Look at levels of participation in community work
- Consider the positives and negatives of networking
- Identify the facilitation role of community development workers

February Training Courses

Working with Outcomes

Thursday 6th February from 10am to 3pm

In today's economic climate understanding and demonstrating your impact will not only help you build good working relationships with funders but can also help you improve your planning mechanisms resulting in more effective service delivery. This training course will introduce you to the steps involved in planning, managing and developing an outcomes approach to your work.

By the end of the session, you will be able to:

- Understand the benefits of using an outcomes approach
- Describe the activity, results and difference your work will make
- Design and implement a monitoring and evaluation system for gathering and analysing information

Public Access Defibrillator Awareness
